

**ASHWINI VAISHNAW** is currently the Union Cabinet Minister for Railways, Communications, Electronics & IT. He was elected unopposed to the Rajya Sabha (Upper House) in June 2019. He represents the Eastern State of Odisha. Mr. Vaishnaw brings blend of experience in government entrepreneurship and public services.



In his early career as an IAS officer, Mr. Vaishnaw earned the reputation of executing development programmes with active

participation of people at the grassroots. For instance, his team in Balasore effectively used technology and mobilized people during the Odisha Super Cyclone of October 1999. Mr. Vaishnaw used the data available on US JTWC website to accurately track the path of the Super Cyclone. He engaged with the people living in the villages that were located in the path of the cyclone, mobilized them and evacuated more than half a million people just before the cyclone hit the coast. This helped in saving thousands of lives. The strategy of evacuation was then adapted as a standard operating process throughout Eastern India, which is frequently hit by cyclones.

His work in districts of Sundergarh, Balasore and Cuttack was highly appreciated and he was selected to work in the Prime Minister's Office.

In Prime Minister Vajpayee's Office, Mr. Vaishnaw focused on developing infrastructure in public-private partnerships. He was part of the team that set-up the framework which led to development of thousands of kilometres of world class highways, sea ports and airports in India. After serving Mr. Vajpayee, Mr. Vaishnaw led the operation and development of Mormugao Port Trust, a major sea-port on the West Coast of India. Here, he conceived and developed projects for Cruise terminals, Coal terminal, and modernization of Iron Ore terminals.

In his corporate and entrepreneurial journey, Mr. Vaishnaw worked in the railway, urban infrastructure, and manufacturing sectors.

Mr. Vaishnaw earned his MBA from the Wharton School of Business, University of Pennsylvania, USA and Masters in Technology from Indian Institute of Technology, Kanpur, India.

**CARL BENEDIKT FREY** is a Swedish-German economist, economic historian, speaker and author. He is based at Oxford University.

Carl Benedikt Frey is Oxford Martin Citi Fellow at Oxford University where he directs the programme on the Future of Work at the Oxford Martin School.



After studying economics, history and management at Lund University, Frey completed his PhD at the Max Planck Institute for Innovation and Competition in 2011. He subsequently joined the Oxford Martin School where he founded the programme on the Future of Work with support from Citigroup. Between 2012 and 2014, he was teaching at the Department of Economic History at Lund University.

In 2012, Frey became an Economics Associate of Nuffield College and Senior Fellow at the Institute for New Economic Thinking, both University of Oxford. He remains a Senior Fellow of the Department of Economic History at Lund University, and a Fellow of the Royal Society for the Encouragement of Arts, Manufactures and Commerce (RSA). In 2019, he joined the World Economic Forum's Global Future Council on the New Economic Agenda, as well as the Bretton Woods Committee. And in 2020, he became a member of the Global Partnership on Artificial Intelligence (GPAI) — a multistakeholder initiative to guide the responsible development and use of AI, hosted by the OECD.

In 2013, Frey co-authored "The Future of Employment: How Susceptible Are Jobs to Computerization", estimating that 47% of jobs are at risk of automation. With over 10,000 citations, the study's methodology has been used by President Barack Obama's Council of Economic Advisors, the Bank of England, the World Bank, as well as a popular risk-prediction tool by the BBC. In 2019, the paper was debated on the Last Week Tonight Show with John Oliver.

Frey has served as an advisor and consultant to international organisations, think tanks, government and business, including the G20, the OECD, the European Commission, the United Nations, and several Fortune 500 companies. He is also an op-ed contributor to the Financial Times, Foreign Affairs, Scientific American, and the Wall Street Journal, where he has written on the economics of artificial intelligence, the history of technology, and the future of work.

After working for three years he did his post-graduation from IIM Ahmedabad in 1989 and joined the consumer marketing firm HMM Ltd. (now called Glaxo SmithKline Consumer Healthcare Ltd.). He quit his job for entrepreneurship eighteen months later and co-founded Info Edge.

For the first seven years as an entrepreneur, Sanjeev drifted and did a number of small businesses – from salary surveys to databases, to feasibility studies, to training. For a brief period, he was the Consulting Editor of Avenues – the careers supplement of 'The Pioneer' newspaper.

In 1997, Info Edge launched Naukri.com and transformed itself into an Internet company. Starting off from a servant quarter above a garage and with seed capital of two thousand rupees, the company grew and attracted investment from leading venture capitalists. It was the first Internet company to list on Indian stock exchanges. Today Info Edge employs over 4500 people and has a market capitalization of over USD 8 billion.

Sanjeev is active in various industry forums and is a contributor to the entrepreneurship ecosystem. He has served as the President of the Delhi chapter of TiE (The Indus Entrepreneurs). He has also served as a member of the Global Board of Trustees of TiE.
