Panel Discussion 1: Facilitating a Robust Framework for Cross-Border E-Commerce to enable MSMEs.



MR. RAJESH AGGARWAL is a Visiting Professor (Trade) in ICRIER. He served at the International Trade Centre (UN-WTO) for 18 years as Head of the Business and Trade Policy. Before serving at the ITC, Mr. Aggarwal worked in the Government of India / State Government for over 22 years, including leading negotiating in key areas such as Agriculture, TRIPS & Public Health, and Rules during his stint at the Indian Mission to WTO in Geneva.



DR. RAJAN SUDESH RATNA is presently working as Deputy Head of South and South-West Office of UN ESCAP, New Delhi since August 2018 and leading research, policy advisory and capacity building on helping countries accelerate progress towards achieving the Sustainable Development Goals. He has led the capacity building programme of training more than 3000 women entrepreneurs from Micro, Small and Medium Enterprises (MSMEs) of South and South-

West Asia for using digital marketing and e-commerce platforms for promoting their business and becoming part of national, regional and global supply chains.

Banerjee is a member of the National Trade Facilitation Steering Committee and was most recently a special invitee to the Committee on Ease of Doing Business Reforms constituted under the Ministry of Commerce as a part of Prime Minister Modi's initiative on reforms. He serves as executive member of the Federation of Indian Chambers of Commerce and Industry (FICCI) Logistics Task Force, and he led FICCI's interaction on Goods and Services Tax (GST)-related issues relevant to the transport and logistics sector, focusing on operational aspects of GST implementation. He also serves as guest faculty at the Indian Institute of Foreign Trade (IIFT), Foreign Services Institute (FSI), and NACIN (National Academy of Customs, Indirect Taxes, and Narcotics). Banerjee has a PhD in public policy, and master's and undergraduate degrees in economics. He has been extensively published on issues related to international trade, regional integration, regulatory reforms, logistics and connectivity, and trade facilitation.



DR. previously worked at the GATT/WTO for 20 years with the last 8 years as Deputy Director General, served as the Secretary Telecom Regulatory Authority of India, the Executive Director of Brookings India, was the Chair of GATT/WTO Dispute Settlement Panels, a Senior Fellow at think tanks in Switzerland and Canada, and taught at universities in the US and China.



MRS. K. RATNA PRABHA is a 1981 batch Indian Administrative Service (IAS) officer of Karnataka cadre. Through her years of service, has gained immense and varied experience in various sectors of government, especially IT, Industry & Commerce, Skill Development and Women Entrepreneurship. Interaction with Policymakers on E-Commerce an Enabler for Growth and Exports

MR. SUMANTA CHAUDHURI is a retired IAS officer, having two decades of experience in international trade issues. He was Joint Secretary as well as Director in the Department of Commerce, Government of India and handled Trade Policy Division dealing with WTO issues and Regional and Bilateral trade engagements including the negotiations on Regional Comprehensive Economic Partnership (RCEP). Panel Discussion 2: Ensuring Consumer Protection in the Age of E-Commerce

DR. RUPA CHANDA is the Director of Trade, Investment and Innovation at UNESCAP. She has worked as an Economist at the IMF and briefly served as Head, UNESCAP Subregional Office for South and South-West Asia in New Delhi. Her research interests include the WTO, trade in services, regional integration and migration. She has undertaken research and professional assignments for international and Indian organizations and has published extensively in the form of books,



journal articles, book chapters, and reports. She is active professionally as a research guide, reviewer, and member of several expert committees. She was member of the WHO's Review Committee on the functioning of the International Health Regulations (2015-16) and the WHO's Expert Advisory Group, International Recruitment of Health Personnel (2019-20).

DR. ADAM TRIGGS is the Founding Partner at Mandala, a business consulting company offering distinctive economics, policy, and strategy capabilities. He is also a non-resident fellow in the Center for Sustainable Development, housed within the Global Economy and Development program at the Brookings Institution. He is based in Canberra, Australia, where he previously served as the director of research at the Asian Bureau of Economic Research at the Australian National University.



His academic research focuses on macroeconomic cooperation between countries, financial risks and safety nets, competition (antitrust) policy, and trade and financial integration, with a particular focus on Asia. Triggs is widely published in leading economics journals and is a regular contributor to media outlets in Australia, Asia, and around the globe. In previous roles, Triggs worked as an economic policy adviser in the Australian Prime Minister's Department, an economic adviser to the Shadow Assistant Treasurer of Australia, an economist at the Australian Competition and Consumer Commission in mergers and acquisitions regulation, and an adviser on Indigenous policy at the Cape York Institute. He has also worked as a consultant to a variety of companies, banks, and government departments in Australia. Triggs holds a bachelor's degree in law, a bachelor's degree in economics, a master's degree in international economics and a Ph.D. in macroeconomics from the Australian National University.



DR. SANJAY KATHURIA is a Visiting Senior Fellow in the Growth, Finance and Development vertical at CSEP. He has a vast experience of more than 40 years and is recognised as a pre-eminent thinker and commentator on economic development, growth and integration in South Asia. His research interests and writings have focused on South Asia, economic growth and development, industrial policy and competitiveness, trade and globalisation, regional

integration, the economics of small states, and gender issues, among others.

He is also Visiting Expert with the United States Institute of Peace. He teaches in both the US and India, as Adjunct Professor, Georgetown University, and Visiting Faculty, Ashoka University. He is also a Non-Resident Senior Fellow at the Institute of South Asian Studies at the National University of Singapore and a Global Fellow at the Wilson Centre in Washington, DC.

Earlier, Sanjay Kathuria was Senior Visiting Fellow at the Centre for Policy Research, New Delhi. He was a Lead Economist at the World Bank in Washington, DC, where he spent 27 years working on South Asia, Latin America and the Caribbean, and Eastern Europe, including field assignments in New Delhi and Dhaka. Before joining the World Bank, he was a Fellow at the Indian Council for Research on International Economic Relations in New Delhi, from 1982 to 1992.

He holds a PhD in Economics from Oxford University as an Inlaks Scholar. He graduated from St. Stephen's College, Delhi, and completed his Master's at the Delhi School of Economics.

Apart from many books and reports published at the World Bank, his writings have featured in Foreign Policy, Hindustan Times, The Indian Express, The Wire, Daily FT (Sri Lanka), Business Standard, among others. He is currently working on a new book on The Future of South Asia.



DR. ARCHANA G. GULATI is an international digital policy and regulation expert with over 33 years of experience. She was previously an Indian Civil Services officer (1989 batch) and retired voluntarily in 2021. Dr Gulati headed public policy and was a Director at Google India. Panel Discussion 3: E-Commerce Trade and Cross-Border Data Flows

MR. SANJEET SINGH is Senior Advisor with National Institution for Transforming India (NITI Aayog). He looks at policy issues related to Trade & Commerce as well as Economic & Finance and Disinvestment related issues. He is also the Coordinator for NITI Aayog for India's G-20 Presidency related matters. He is also charged with all matters relating to International Cooperation and Strategic Economic Dialogue conducted with various countries.



He is an Indian Revenue Service officer of the 1991 batch. He has worked with various Government departments in addition to his parent Department of Income Tax, including Department of Commerce where he worked extensively on the policy and its implementation of Special Economic Zones policy framework. He also dealt with East Asia Division where he was instrumental in promoting trade and investment related issues with China, Japan, Korea, Australia, Taiwan among others. Earlier he had served with the Ministry of Rural Development where he dealt with establishing the policy framework and its implementation with various States in India for the flagship Rural Roads programme – the Pradhan Mantri Gram Sadak Yojana or PMGSY with the objective to provide good all-weather road connectivity to all unconnected villages of the country - 178,000 habitations with a population of above 500 in the plains and above 250 in the hilly areas. He has also served as Advisor at the Telecom Regulatory Authority of India, TRAI.

He is a post graduate in Physics from St Stephens College, Delhi.
