The October 2019 Issue of the Newsletter provides a quick recap of ICRIER's research and policy engagements during the month of September 2019.

ICRIER organised a stakeholder consultation on 3rd September to discuss "The Role of Standards in Diffusion of Emerging Technologies: Internet of Things (IoT)"; commissioned by the Department of



Science and Industrial Research (DSIR). A concise overview of the evolution of IoT ecosystem (India and globally), the importance of standardization and role of standard development organizations (SDOs) was presented followed by interaction with experts.

Also on 3rd September, a stakeholders' consultation workshop on "Exploring Cost-Reduction Strategies for Electric Vehicle (EV) Batteries" was organized in Bengaluru jointly by ICRIER and IIM, Bangalore. The global trends in EVs and various strategic and policy options to reducing cost were discussed. On 4th September, Dr. Mihir Shah, former Member, Planning Commission delivered a talk on "Solutions to India's Water Crises" as a part of ICRIER's 'Conversations in Urbanisation' series.

Dr. Isher Ahluwalia, Chairperson, ICRIER delivered a keynote address at the 4th South Asia Economic Network Conference on "Subnational Finance and Local Service Delivery", organised by the World Bank on 7th and 8th September in Dhaka, Bangladesh.

On 16th September, ICRIER in partnership with DoT, COAI and TAIPA organized a regional workshop on "Enhancing Digital Infrastructure" along with States and UTs" at Chennai. A stakeholder's consultation on "Domain Name Market in India: Evolving Trends, Competition Issues and Challenges in the Industry" was organized on 17th September in collaboration with the Centre for Development of Advanced Computing (C-DAC), Mumbai.


On 20th September, ICRIER organized a seminar on "Does choice of contract matter for cost and quality of highways? Empirical analysis of PPPs vs. traditional contracts." Dr. Ram Singh, Professor-Economics, Delhi School of Economics spoke on the relationship between costs and quality of highways and contract type using findings from about 300 projects in India.

On 30th September, ICRIER organized the launch of the book "Low Carbon Pathways for Growth in India" edited by Rajat Kathuria, Saon Ray and Kuntala Bandyopadhyay.

The book explores low carbon pathways for India up until 2030. The book launch was followed by a panel discussion. On the same day, a Stakeholders' Consultation on 'Financing Resilience against Natural Disasters' was held.
