India's GVC integration: An analysis of upgrading efforts and facilitation of lead firms

India presents a unique example of manufacturing capability in most sectors, but suffers low integration into global value chains (GVCs). This paper examines the reasons for India's low integration into GVCs, especially in the manufacturing sector. It argues that one of the reasons for India's low integration into GVCs is its primary focus on the domestic market. The second reason for India's limited participation is the role played by the lead firms. In this paper, we show that while India has several horizontal and vertical policies, there are fewer instances of GVC specific policies which lead to the encouragement of lead firms. The policy implications from the paper are the processes that emerging countries can follow in nurturing lead firms.

The Union Budget 2020-21: Reforms and Development Perspectives

The Union Budget 2020-21 was presented by the Honourable Minister of Finance, Ms. Nirmala Seetharaman on February 1, 2020. Given that India's growth rate has fallen to a decadal low, this budget was crucial. The Government demonstrated intent by convening several diverse groups of stakeholders to gather ideas on the admittedly hard task to nurse the economy back to health. Some ideas were reflected in the Union Budget, while some have been kept in abeyance. The heads of five leading think tanks in the national capital region- Yamini Iyer (CPR), Rathin Roy (NIPFP), Shekhar Shah (NCAER), Rajat Kathuria (ICRIER) and Nishant Chaddha (IDF) -came together to share their reflective view and the longer-term implications for the Indian economy for the 13th time.

ICRIER and Rupa Publications hosted the launch of Montek Singh Ahluwalia's book 'Backstage - The Story Behind India's High Growth Years' on February 19, 2020. The book gives an intimate portrait of three decades of economic reforms in which Dr Ahluwalia played a critical role. The book was launched by former prime minister Dr Manmohan Singh, who spoke about his close association with Dr Ahluwalia and his role in bringing him from World Bank to work in the Government of India. The panel discussion was captivating, skillfully alternating between the past and the present and drawing invaluable lessons for the future of the Indian economy.

Internet Governance in India: People, Purpose and Process

24 Feb 2020

ICRIER with the support of the Ministry of Electronics and Information Technology (MEITY), held a day-long conference on Internet Governance, where Secretary MEITY, Ajay Sawhney delivered the Keynote address. The conference hosted three panels that discussed national and international internet governance priorities for India, and also discussed protection of India's critical internet infrastructure and delineating it from the more commonly discussed critical information infrastructure. The conference deliberated on India's role and participation in internet governance institutions and processes, highlighting the need for greater capacity building, and reviewed India's historical engagements. The discussions concluded by drawing attention to the need to revive and reframe the internet governance discourse in India.




