Asymmetric Treatment: SAFTA vs. Bilateral FTAs

ISFTA	SAFTA
SL allowed negative list of 25% of tariff lines; India maintained 8%	Non-LDCs maintain 20% of tariff lines; LDCs approximately 25%
India offered immediate zero duty concessions on 25% of tariff lines; SL offered only about 6%	No such immediate zero duty concessions
SL gets additional 5 yrs. to implement	LDCs get additional 3 yrs.

Bilateral FTA has proven to be far more liberal

- ISFTA: Less than 14% of SLs exports to India restricted under Indian negative list
- SAFTA: Nearly 42% of SLs exports to India restricted under Indian negative list.
- At present, 93% of SLs exports to India enter under zero duty under ISFTA

SL sees significant export expansion to India following ISFTA

- Export earnings increase from US\$ 60mn in 2000 to US\$ 570mn by 2005.
 - Increase of 64% p.a. on average compared to increase of 3.3% to ROW.
- However, expansion driven by 2 commodities
 - Vanaspathi jumps from 1% of exports to 25%
 - Copper/articles jumps from 3% of exports to 50%

Growing opportunities for intraindustry links clear

- Automobile industry
 - Influx of Indian-made automobiles into SL
 - Plans to set up assembly operations in SL
 - Joint ventures already established in ancillary products like tyres
 - Chinese automobile assembly also entering SL market
- ISFTA gave initial boost to encourage expansion of such activities

Spillovers into FDI

- Indian FDI in SL accounts for 6% p.a. during 2004-06 compared to 1% p.a. earlier
- Over 70% of Indian FDI now in services
- Prompted moves to negotiate a bilateral CEPA

 Provision only to 'review'; does not require a binding commitment to reduce over time.

Time frame

- SAFTA to be fully implemented by 2016
- More dynamic bilateral/other regional FTAs emerging
- Some of the smaller SAARC countries may stand to benefit from FTAs with India
